# **Descendants of Jean Gaury**

## **Generation 1**

1. **JEAN**<sup>1</sup> **GAURY** was born about 1645 in Soubise Province of Saintonge, Charente-Maritime, France. He died between Mar-Jun 1709 in Manakin, Henrico County, VA. He married Mary Rue about 1675 in Soubise, Saintonge, France. She was born about 1660 in France. She died before 1716 in prob. Manakin Virginia Colony.

### Notes for Jean Gaury:

Jean Guerry was born in the village of Soubise, in the ancient Province of Saintonge, in Frnace about 1645. He left France before 1685, and came to the Colony of Viginia in 1699/1700 accompanied by two sons, Pierre and Claudius. Jean Guerry and his sons were millers of grain, a trade that continued in the family for more than a hundred years.

In the first hundred years the name was spelled many different ways, but by the late 1700's it had become Goree, though some of the decendants now spell the name Goray and Gore.

The descendants of Jean Guerry and his sons, Pierre and Claudius, migrated from Virginia to South Carolina, then to Georgia, Alabama, Mississippi, Louisiana, Texas and Illinois during the 1800's.

All of the Gorees in the United States are descended from the Jean Guerry, or from pre Civil War Slaves of White Goree families in South Carolina, Georgia, Alabama, Louisiana and Texas.

"Jean Gaury, sa femme, et un enfant" is on the list of French Huguenot refugees on board the ship [IT:Mary Ann:IT] that landed at Jamestown July 31, 1700. The refugees, part of a shipment of four boatloads, actually settled several miles up the James River, a little less swampy area, that they named Manacan after the Indians recently displaced there. Huguenots, or French Protestants, had been starved and slaughtered out of France, escaped to England, and then resettled wherever they could find passage. Earlier groups had gone to New Amsterdam, Massachusetts, South Carolina, and finally Virginia and Delaware. Proof of descent from this ancestor will make descendants on this line eligible for membership of The Huguenot Society. On the same ship was his son Pierre, wife and young baby. His other son, [BO:Claudius:BO], was a teenager. His will, probated March 20, 1709 in Henrico Co. refers to him as a French refugee of Manakin. In it he leaves 80 acres to wife Mary Rue during her life time, eldest son Peter (Pierre) to receive only one shilling, younger son Claude Gory to have the land on death of his wife. Just as a side note, such a minor bequest doesn't mean a child was cut off, but usually means that child had already received a suitable distribution of assets. It is seen frequently in wills of that time.

In the name of God, Amen. I, John Gory Senr: of the County of Henrico, French Refugee and inhabitant of the Manakin Town being sick & weak in body but of sound and perfect memory do make this my Last Will & Testament in manner and form as followeth. First I comitt my soul to Almighty God that gave it, and my body to the Earth, and as for my Worldly Goods I give as followeth. I give and bequeath my Plantation whereon I now dwell being eighty acres or thereabouts scituate in the Manakin Town and County above said unto my Loveing wife Mary Rue Gory and all my

other estate of goods and chattels both moveable and immoveable duringher natural life (Except one shilling which I give to my elde son Peter Gory) and at or after the death of my said wife then I desire that my son Claud Gory shall have and possess my said land which I give and bequeath to him and his heirs forever, and all my other estate after his mother's decease. I likewise appoint my loveing wife Mary Rue Gory and my son Claud Gory Executrix and Executor of this my last will and testament and in Witness whereof I have hereunder Set my hand and Seale this twentieth day of March Anno 1708/9

i. UNKNOWN<sup>3</sup> GAURY was born in Europe. Unknown died about 1700 in Virginia.

Notes for Unknown Gaury:

A child brought in the "Mary and Ann" on the voyage to Virginia apparently died shortly after arrival in 1700.

ii. ISAAC GAURY was born about 1703 in Virginia. He died about 1738 in Virginia.

Notes for Isaac Gaury:

Entries made in 1737 and in 1738 church records indicate Isaac is an invalid; possibly ill and dying. Jan. 1880

AN ENTRY IN THE VESTRY BOOK OF KING WILLIAM PARISH DATED 21 APRIL 1738 INDICATES THAT ISAAC GORI IS ILL, AND HIS DEATH PROBABLY FOLLOWED SHORTLY THEREAFTER. THERE ARE NO FURTHER ENTRIES CONCERNING ISAAC, AND NONE AT ALL THAT INDICATE HE WAS MARRIED OR HAD CHILDREN . LJG files.

Notes for Claudius Gory:

Source Internet, Gene Ballentine Rooks <GeneRooks@prodigy.net> Claudius was under legal age when his family arrived in Mannikin. By 1714 when a record of inhabitants of Mannikintown was taken, Claude Garry and wife, whose name is believed to be Jeanne, were shown. In 1716 he purchased 50 acres on the s. side of the James River, then in Henrico Co., in King William Parrish. Through the years following he is found on the tax lists, once is mentioned as objecting to a road change, once assigned to keep the road cleared, and once paid for cleaning the church In 1735 he sold the 50 acres and bought an additional 192 acres. This area later fell into Goochland Co. He died not long after. The inventory of the estate of Claudius Gory in 1737 is available from Goochland Co., I have not yet located a transcript. Known children are [BO:Daniel:BO], James and John, and Madeline.

Proof of Daniel is contained in Deed Book 4, Goochland Co., Va. 1731-1745, p. 302, as follows: March 10, 1743 [BO:from Daniel Gory of Goochland:BO] to Joseph Bingley of Goochland, for 19 lbs, a certain tract of land of 192 acres on the s. side of James River in Goochland, joining Francis Forceys deceased, and Stephen Forceys and John James Dupute, and also joining Joseph Bingley, [BO:(and is) the land that Joseph Bingley did formerly sell to Claudis Gory, the father of the above Daniel Gorey. Signed Daniel Gorry.:BO] Wit. Stephen Watkins, John Panmkey, Peter Dapp Jr, Stephen Hughes, David Lesueur, recorded Mar. 20, 1743.

AN INVENTORY OF THE ESTATE OF CLAUDIUS GORY DATED 8 JULY 1737 CONFIRMS HIS DEATH PRIOR TO THAT DATE. LJG files

IN A DEED DATED 10 MARCH 1743, CONVEYING 192 ACRES OF LAND TO JOSEPH BINGLOY, AND PURCHASED IN 1735 BY CLAUDIUS GORY FROM BINGLOY, IT IS STATED THAT CLAUDIUS IS THE FATHER OF DANIEL.

Notes for Jean (John) (Gaury) GOREY:

The records of this period show this John as John Gorey, Senior, and his younger first cousin, John who married his grand daughter, Lucy Lyles Lyles, as John Gory, or Gorre. LJG files.

IN THE BAPTISMAL RECORD OF THE MANAKIN CHURCH, AND DATED 21 May 1727: "Was born Jean Gori, son of eglan and of Jeanne, his wife, was baptized by Mr. Neirn, Minister of the Holy Evangelist; was presented by Jean Pierre Bilbau and Elizabeth Dutoi." An examination of a photograph of the original document, and a more precise translation by Mrs. Susan Riggs, Assistant Curator of Manuscripts at the Virginia Historical Society, confirms that the name shown as Eglan in translations is, indeed, Claud. This confirms the birth of John, and Jeanne as the wife of Claudius. LJG files.

IN 1750 JOHN GORY FIRST APPEARS IN THE LIST OF TITHABLES IN LUNENBERG COUNTY, IN SOUTHERN VIRGINIA, AND HE CONTINUES TO APPEAR IN THE LISTS OF TITHABLES AND OTHER RECORDS UNTIL 1765. DANIEL LAST APPEARS IN THE RECORDS OF LUNENBURG COUNTY IN 1767.

In 1765 John Gore and wife, Sarah, sell land to Amos Mix.

Chronologic allows the prsumption that James is the son of Claudis, but he could be of the English Gore family moved to Goochland County, Virginia, from Accomack County, or from Maryland. LJG files.

And to my son William GORRE I give and bequethe the fether bed that I ly on and the furniture and balance of my moveable Estate to be Equally devided between my too Sons namely William GORRE and John Owen GORRE and that I do hearby utterly disallow revoke and disannull all and every other former testaments will or bequest Ratifying and Confirming this and no other to be my Last will and testament. In witness whereof I have hearunto set my hand and Seal this tenth Day of June 1800.

The above named William and John Owen GORRE I leave as Executers to my Will.

Note: Information supplied by (Ms.) Gene Rooks, P. O. Box 146, Gotha, FL 34734: Having sold in 1743 the property inherited from his father in Goochland Co., Va., Daniel and his wife Elizabeth Britton soon relocated to old Lunenburg Co., VA, which became Mecklenburg Co. in 1765. He assisted appraising the inventory of John Pankey in 1750, who had witnessed the sale of his Goochland property in 1743. His brother John is shown with him on the tithable list of 1752. He received a patent for 550 acres of land on both sides of Allens Creek in 1755, which he sold the next year. His wife's name of Elizabeth appears relinquishing her dower rights to this property. He bought and sold property in that county several times until 1767, often with his brother John appearing as a witness.

He is next found in Mecklenburg, VA, and then is found in Newberry, SC on a 1779 jury list, on a land deed when he purchased a 300 acre plantation on Kelley's creek, and on the 1790 census., with two males over 16 and six females. A review of the will book of Newberry Co. SC in the late 1700's shows his name often as witness or attending estate sales, in close proximity with the name of Lewis Hogg, who his daughter later married, Owen names, and the first names of Claudius, Clarissa, and Britton, repeated in related Goree families. One of the estate sales was that of his brother John, who joined in the removal to Newberry Co. Daniel and Elizabeth had the following children, Agnes Kelly, who was previously married to Thomas Durrett, grandson of Francis Durrett, another Huguenot emigrant,

Mildred Lyles, Molly Kelly, Selah Parrott, Jane Johnson, William, John Owen., and [BO:Clarissa Hogg:BO]. His will, probated March 19, 1801, Newberry District SC, Will Book C, p. 356 mentions "Daughter Clarrissa Hogg, one shikling."

DANIEL LAST APPEARS IN THE RECORDS OF LUNENBURG COUNTY IN 1767. In 1767 Daniel Gory and wife, Elizabeth, sell land to John Freeman.

IN 1777, AND IN MECKLENBURG COUNTY DEED BOOK 15, PAGE 10, APPEARS THE FOLLOWING ENTRY:

"Robert Mumford to Joshua Moss. ... for consideration of 200 pounds. ..360 acres ...together with the grist mill purchased by Robert Mumford of Daniel Gorre ."

Apparently the trade of miller continues to be followed by the descendants of Jean Guerry, the miller. Grist mills were owned and operated by Gorees in South Carolina, and in Alabama until the mid 18001s.

I don't know when Noah came back to TX, but both George and Noah were killed in a "gasoline explosion" according to their 1936 death certificates. I did some internet querying and corresponded with a former GOREE daughter-in-law (still trying to get some closure on that marriage to a GOREE). The story (I wasn't there, I don't know, I'm only repeating) is a grand jury was convened but apparently did not indict. Noah's half brother, George Washington GOREE, was suspected of bashing a head or two with a shovel and torching the building. Hidden money was reportedly involved (end of story).

Noah's other half brother Charles Ewing GOREE died in 1934. He is listed in 1933 Bexar co TX lunacy records. A number of first and second GOREE cousins show up in institutions (state hospital, mental) in the late 1880s and early 1900s. I suspect some sort of genetic medical problem, such as seizures but haven't ever heard from family members about it. Do you have info on the above?

OK, so Noah's father was George Castle GOREE and you've probably seen on the internet where his father is reported to be George also. That came from George's death certificate and is inaccurate. I don't know when Noah came back to TX, but both George and Noah were killed in a "gasoline explosion" according to their 1936 death certificates. I did some internet querying and corresponded with a former GOREE daughter-in-law (still trying to get some closure on that marriage to a GOREE). The story (I wasn't there, I don't know, I'm only repeating) is a grand jury was convened but apparently did not indict. Noah's half brother, George Washington GOREE, was suspected of bashing a head or two with a shovel and torching the building. Hidden money was reportedly involved (end of story).

Noah's other half brother Charles Ewing GOREE died in 1934. He is listed in 1933 Bexar co TX lunacy records. A number of first and second GOREE cousins show up in institutions (state hospital, mental) in the late 1880s and early 1900s. I suspect some sort of genetic medical problem, such as seizures but haven't ever heard from family members about it. Do you have info on the above?
